Key points: Port operations all good and operating in the GREEN!

There have been repeated efforts by the industry (NRC) and POAL to bring some sense to AT's decision to cone the front entrance of Tamaki Dr and coming off The Strand. They have done this to supposedly protect pedestrians and cyclists for social distancing and yet they are creating far more concerning risks for trucks and unnecessary congestion. For the trucking community please be extra careful when entering and exiting Fergusson Terminal. Drivers have been doing a great job to manage this risk but please be extra vigilant.

Marine Services

All shifts covered. Pilot times may alter, but generally running to schedule.

Container Terminal Operations

Berth windows and vessel schedules – Vessel operations working and no ships on berth until this evening. We have a busy period from midweek with late arriving Kota Lembah (NZS/KIX Service) from Wednesday and 2 late arriving MSC vessels (Aditi and Genova) with the usual JKN/NE Asia Service on Friday including ANL TTZ and a bigger exchange on NZS/KIX vessel on Sunday due to last weeks blanked sailing. ANZEX/CNS vessel no due until Monday. Please continue to closely monitor via POAL website www.poal.co.nz

Labour supply - still meeting demand, team are working well. Yard Capacity – Yard capacity at Terminal approx. 57% this morning. We are also starting to hand back some of the north terminal yard capacity to the Automation team as the project restarts. We will be focussed on reducing any yard utilisation over the next 2 days to ensure we keep on top of demand for the rest of the week.

Road Services – road operating well. Approx. 250 odd import containers removed from the Terminal over the weekend. We have tried to provide

more capacity today but were limited due to road constraints on The Strand. Truck turn times over the weekend and up until this morning under 20 mins. We would ask Carriers to already start planning for a big weekend ahead and identifying where you can capitalise on weekend and night-time collections/VBS capacity.

Please note: Only one driver at a time is allowed into the Fergusson Road Office. Drivers MUST always keep 2 metres apart when waiting outside the Road Office, Kiosks and Multi-Cargo.

The Container Terminal import container demurrage terms remain, applied 3 calendar days after the container has been discharged. To ease the burden, demurrage is now a flat daily rate of \$70 per TEU. Whilst we are still all operating under constrained circumstances with Level 3, we will extend these demurrage terms to the 31st May 2020.

The LINK remains closed to empty import dehires only.

Remember please only essential visitors to the port and you must adhere to our protocols to ensure safe hygiene. Our access protocols have <u>not</u> changed for Level 3. Access Permit controls are required for all contractors, who have not accessed the Port during Level 4. Please ensure to engage with the POAL party whom you would be reporting to before attempting to enter the Port.
